- (f) Physically handicapped certificate showing 40% and above disability issued by competent authority if applicable.
- (g) Discharge certificate in case of Ex-serviceman.
- NOC in original from their present employer/competent authority in case of Government servant including serving (h) Armed Forces Personnel if applicable.
- Address proof (Passport/ Ration Card/ Voter Card/ Driving License).
- 30. Candidates on selection are liable to be transferred anywhere across India including field services liability and not necessarily at the choice of location given at time of application.
- Any representation for redressal of grievances with regard to the recruitment will be subject to the jurisdiction of the 31. District Court of respective stations where candidate has submitted the application.
